### **Reports**

#### 1. Chairman's Report

AvW welcomed all to the meeting. There has been some progress on a number of activities including development of the new VRA website. A pre-production version should be available by the end of January 2021. This will be distributed to Councillors and a number of members to use and spot errors. This is part of our quality assurance process. The online shop is in its final state and the POS system is now installed at the shop with the photos nearing completion. It would be great if we could have a Councilor dedicated to the rollout of all this new technology. I visited Bendigo last Wednesday to hold our first operational meeting with the Shop Manager, Exec Officer, and new Treasurer. DdK and the Shop Manager will have regular catch ups to develop some strategic planning around the future of the shop.

I am hoping to finalise portfolios today and it will be my expectation that you report back on progress at each meeting. We need a clear idea of the work ahead of us and I am hoping we can work collectively to achieve those goals.

I was in attendance as an impartial observer of a special general meeting at the Lang Lang RC on the 19<sup>th of</sup> December 2020. There was one individual who was not a VRA member in attendance at that meeting whose behaviour will not be tolerated. This person was invited in good faith. In the future any person acting in an intimidating or inappropriate manner will be asked to leave the meeting. We should take a hard stance on formalizing action against those individuals and they will not be permitted to join any VRA club.

Furthermore, I want to speak in general about the conduct of our members. As a Council we need to be beyond reproach and act with full transparency using best practices within the industry. The fact that we are giving our time does not mean we should accept that we are the target of anyone's tirades. I won't accept any Councilor is spoken to in the manner that Councillors were spoken to in the AGM That conduct will subject to formalized processes as well.

As a follow up to the Wellsford shooting rights, I have been in constant contact with DEWLP since December 2020, who have informed us that Parks VIC is the lease holder of the fallout area. I have received formal correspondence that they have initiated the new lease.

The grants submission is nearing its completion. The number of electronic targets we originally were going to purchase was 28, however I believe we should reduce that to 20 or 24 targets with the remainder of the funds to purchase 20 or 30 shot maker systems. This will allow clubs to use the shot maker systems when they do not have the Hexta infrastructure. We can then service a broader club base.

The new online shop will come live after the stocktake scheduled for 4 Feb 2021.



#### 3. Shop Report

AvW spoke about the shop report that had been provided by the Shop Manager.

#### **Popular Products**

Our best sellers have been Projectiles (\$75,212.82), with NRAA projectiles only contributing to 16% (\$20,961.06) of the total sales. This was then followed by powder sales, which was restricted due to the unavailability of stock.



#### **Supply**

There has been over the last couple of weeks a steady increase in the availability of stock from suppliers and more primers, projectiles, and powders are being restocked on our shelves. However, with this we have also seen prices increase, some quite dramatically, as suppliers only have limited numbers, due to most products coming from or via America.

Due to this we have acquired some different brand-named products and tried to source more projectiles and cases. As a result, we now stock such as Peterson and ADI cases are now on our inventory list and we look forward to seeing some Copperhead projectiles in the shop.

We are still waiting on several backorders from Nioa, mainly Federal primers which currently have no know arrival date yet, and the NRAA and Q-Store for some Bergers mainly 7mm 180gr and FB 155.5gr (500). The Berger's have arrived on Australian shorelines, but it is not yet clear how many we are to receive or when.

I have been checking in with suppliers every fortnight to check their supplies levels and to see an arrival date has been received.
